

## **Application- and tuition fees for citizens in countries outside the EU/EEA and Switzerland.**

**Applicant who is a citizen in a country outside of the EU, EEA or Switzerland** must pay an application fee of 900 SEK when applying to Swedish higher education at undergraduate or advanced level.

The application fee should be paid when making an application to The Royal Institute of Art. The payment must be at KKH's account at the latest by the date of the application deadline.

NB: Application from a person liable for payment will not be handled, unless the payment has reached KKH in due time!

The tuition fee is 307 000 SEK per academic year (153 500 SEK per semester). It should be paid per semester and before the student begins/continues studying at the college.

### ***Mode of payment of the application fee:***

*From Sweden:*

Transfer 900 SEK to Kungl. Konsthögskolan, Bankgiro account: 5188-1498.

*International transaction:*

State the following IBAN number and BIC data:

BIC: DABASESX.

Please do not forget to state your name and which programme you are applying to.

### **Exemptions from the liability for payment:**

You do not have to pay a fee if you:

1. have a permanent Swedish residence permit
2. have a temporary Swedish residence permit granted based on something other than studies
3. are a family member of a citizen of an EU or EEA country who has a temporary or permanent right of residence in Sweden
4. are a family member of a Swiss citizen and have a residence permit in Sweden
5. have a long-term resident status in Sweden
6. have a long-term resident status in another country in the EU/EEA and have a Swedish residence permit
7. are a student at a university or university college outside of Sweden and will be studying as an exchange student in Sweden on a temporary basis as part of an official study abroad programme
8. study within the framework of an exchange programme where no tuition fees should be charged, per a decision made by the government.

**Swedish citizen** does not have to pay either an application- or study fee. The Swedish civil registration number must be stated in the application. If you have emigrated from Sweden and are no longer registered in Sweden, you must prove your Swedish citizenship by sending in a copy of your Swedish passport or a birth certificate from the Tax authority, showing your citizenship.

If you hold a residence permit or right of residence but do not have a Swedish civil registration number, you must submit either of the following documents:

- a copy of the first page of the decision from Migrationsverket showing that you have residence permit on other ground than studies
- a copy of your residence card or the decision from Migrationsverket showing that you have the right of residence

**Citizen in a Nordic country** (Norway, Denmark, Finland and Iceland) does not have to pay either application- or study fees. However, you must verify your citizenship by sending a copy of a valid passport or another document (see below under Passport or ID-card).

**Citizen in an EU or EEA country or a Swiss citizen** does not have to pay either application- or study fees. However, you must verify your citizenship by sending a copy of a valid passport or another document (see below under Passport or ID-card).

### **Passport or ID-card**

To prove your citizenship, use one of the following documents:

- Valid passport. For your passport to be considered valid there must not be more than three months from the expiring date of the passport until we receive your copy (for example if the expiry date is October 20 the copy must have reached KKH at the latest January 20).
- In case you cannot send a copy of your passport, you may send:
  - Copy of a valid ID-card that clearly shows your citizenship. For the ID-card to be considered valid it must not be more than three months from the expiry date of the ID-card until we receive your copy (for example if the expiry date is October 20 the copy must have reached KKH at the latest January 20).
